# **Treasurer's Discussion Items**

Mr. Drewyor reported that donations for the month totaled \$1,750 several donations for scholarship funds.

This district spending and revenue trends are on track. The district is at its minimum cash balance with the expectation of receiving the semi-annual real estate tax during the current week. With cuts in the federal rates earnings on district investments are down and are expected to stay depressed.

Mr. Drewyor attended the county Tax Budget Hearing. The district's tax budget was approved.

The district received an Auditor of State Award for its financial reporting for FY19.

Mr. Drewyor reported attending the County School Treasurer's Meeting on January 29, 2020. A copy of the presentation was provided to the board.

Mr. Drewyor noted that under his recommendations he would be asking the board to approve two contracts with North Point ESC for FY21. These contracts are for special eduation services. North Point ESC is the district's largest provider of purchased services.

The board is being asked to approve a resolution authorizing the district to participate in the Ohio School Council bus purchase program.

The annual Tax Incentive Review Council (TIRC) has been held. All of the district's current tax abatemens were reapproved except for the Huron Senior Residences.

# **Superintendent Discussion Items**

Mr. Muratori reviewed details around the district's COVID-19 response. Mr. Muratori discussed the district's operations protocols, communications and plans to reassess as the situation continues. During the first meal distribution the district provided meals for 170 students. There will be meal distribution for the next two Mondays. Spring break will occur as planned.
