Audience/Community Participation

Treasurer's Discussion Items

Mr. Drewyor reported that donations for the month totaled \$2,893 with a donation for After Prom and the Huron Memorial Scholarship Fund.

The district spending and revenue trends are on track. The district has received all of its tax payments and PILOT payments. With cuts in the federal rates earnings on district investments are down and are expected to stay depressed. The impact of the COVID-19 pandemic is still be evaluated. Expectations are that the pandemic will have net zero financial impact in the current school year.

The May Board Work Session is scheduled for May 9, 2020 at 8:00 a.m.

The district will qualify for \$16,400 of state funds for a bus purchase.

The district is exploring the possiblity for applying for a FEMA Public Assistance Grant.

Superintendent Discussion Items

Mr. Muratori reviewed details around the district's COVID-19 response.

- The district remains closed and under stay at home order from Gov. DeWine. While nothing has been confirmed the expectation is that we will not return for the remainder of the school year.
- The ODE has made clear they expect school districts to fulfill the days (either remotely or in person) the identified school days in their originally adopted district calendar.
- Graduation May 29th and Scholarship Night remain on the calendar but will change depending on restrictions put in place – local state or federal.
- Mr. Lamb and his team are reviewing optional dates in June and July. He has also discussed the HBB with the city as an alternative site. Other options depending on restrictions may be a drive thru format. Scholarship awards ceremony may be rolled in to graduation activities again much will depend on restrictions in place.
- Graduating Seniors HB197 provides flexibility for districts concerns for graduation Students who
 successfully complete curriculum requirements foregoing other grad requirements (testing) are
 eligible to graduate. It is up to the HS principal in consultation with teachers to determine if a student
 has successfully completed curricular requirements.
- Teacher and administrator Evals also under HB 197 Those evals that are lacking required component – SGM's; observations or walk throughs – will be rolled over to the 20-21 school year.
- We have agreed with the HEA leadership teacher evals lacking procedural steps such as an
 observation post conference meeting can be deemed complete if both the teacher and principal
 agree.
- Monday over 325 weekly meal packs were distributed. Each pack contained 5 days' worth of breakfast and 5 days. In total almost 1500 breakfasts and 1500 lunches were distributed.
- Shout out to our café staff, director of operations Denise Zielske, Mr. Kucbel and Dr. McDonald for their assistance yesterday.

The Superintendent reviewed Extended Learning - Remote Teaching and Learning Expectations

Topics that dominate conversations in Huron and from what I am hearing from our peers – center around remote teaching and learning. How much content is enough; how should we grade assignments; what is the balance between new content and remedial and enrichment work. There are no easy solutions. Thanks to our principals and curriculum director – The Huron team has created a common-sense approach focusing on the guiding principle – Quality vs. Quantity. Children who have given a good faith effort will not be adversely evaluated – causing harm to overall academic records.
