- ♦ Financial reporting covers all actual revenues and expenditures through August 31, 2019. All trending data is offered from most recent historical data. Enrollment data is offered progressively with two additional years of experience for trending purposes.
- ♦ We have completed two months in the new fiscal year. It is too early to comment on trends with only one month's data. The general fund unencumbered cash balance on 8/31/2019 was \$7,225,728.
- ♦ Donations for the month of August 2019 \$8,046.15 with \$4,235 going to the CC Scholarship Fund in Memory of Scott Klaiber and \$1,593.15 going to the Sandi Lunch Fund in Memory of Sue Whitaker.
- ♦ The periodic negative balances for State/Federal/Local funding are awaiting deposits from ODE. Looking closely at federal and state programs offered through ODE to be sure to have appropriate budgets/expenses in place to close out the fiscal year.
- ♦ In this time of economic uncertainty, Huron City School District must adhere to strict spending disciplines in order to offset the continued volatility in revenues, foundation adjustments and enrollment fluctuations.






