Session

The Board moved into executive session at 3:02 p.m.

Jody Mast, Board Vice President, called the meeting back to special session at 3:44 p.m.

Discussion Regarding District Facilities

Mr. Ruf reported that after the May levy was defeated, there has been discussion regarding closing or relocating students from McCormick Junior High. He decided that he would work on a proposal regardless if the November 2021 levy passed or not. He requested educational scenarios from the building principals. His proposal would send the 3rd grade to Shawnee, 7th grade to Woodlawn, and 8th grade to the High School. This is not a popular recommendation. Other considerations include the delivery of the Ohio Facility Construction Commission's preliminary report on Huron City School's buildings. The McCormick building meets the requirements for building replacement. Mr. Ruf believes that the OFCC will come back with a recommendation of one campus for all grades. This is an emotional issue, but somewhat urgent. A lighting replacement project was put on hold until the OFCC report is final since the district would not want to expend dollars to fund a project for buildings that could be razed or sold.

The OFCC report was alarming regarding the renovations that needed to be completed for each of the buildings. Another issue is that Firelands Montessori Academy is interested in renting the McCormick building to expand its programming. If this were to take place, the Annex could be torn down. The district could look at applying for grant dollars to help pay for that demolition.

Discussions need to take place with community agencies and/or companies that could possibly be interested in renting these spaces for their office use. A staffing study has not been done yet since it has not been decided where students would go. Ideas were shared: bring in superintendents and/or treasurers of districts that have worked with the OFCC, checking with community groups, consulting experts, creating a committee to work with OFCC. The timeline for the Ardagh project is unknown but any tax abatement will keep the school whole. How much is unknown at this time.

What needs to be done next?

- -Creating a Strategic Facilities Planning Committee to focus on long term planning for buildings/grounds for Huron City Schools. Members would include board members who could rotate in and out of the committee, community members, business leaders, and city officials.
- -staffing study to determine what could be saved by moving students out of McCormick. The decision to move any students would need to be made by January/February 2022 in order for this to be possible for the 2022-2023 school year. Because of this timeline, it was discussed by the Board that the 7th and 8th grade for Huron City Schools would remain at McCormick for the 2022-2023 school year.

Next Meeting

The board will meet in a special session on Wednesday, December 15, 2021 at 5:00 p.m. in the Board of Education Conference Room to discuss the search for a treasurer.

The next regular meeting of the Huron Board of Education will be December 21, 2021 at 6:00 pm. The meeting will be held in the Huron City School District Board of Education Conference Room.
